INTRODUCTION

In its Order No. 32053, Ruling on RSWG Work Product, in Docket No. 2011-0026 ("Order"), the Commission required that Hawaiian Electric, Hawai'i Electric Light, and Maui Electric (collectively, the "Hawaiian Electric Companies" or "Companies") file monthly reports providing details about Interconnection Requirements Studies ("IRS") so that the Commission may monitor the functioning of the IRS process.¹ The monthly Report includes the following information identified in Order 32053:

- Total number of interconnection requests
- Number of interconnection requests for which an IRS is required
- Date each IRS was initiated
- Maximum kW electrical output of the applicable generating system
- Distribution substation and circuit serving each project
- Proposed in-service date
- Length of time an IRS has been pending
- Explanations as to circumstances causing any delays in performing the IRS

The Report also includes the following items requested by Commission staff at a subsequent meeting.

- Mitigation measures to be applied to each system
- Cost of mitigation measures that are applied on the utility-side of the interconnection

- Cost of IRSs.
- Rate schedule of the interconnection request
