Subject: Hawai'i Electric Light Energy Cost Adjustment Factor for July 2018

Hawai'i Electric Light Company, Inc.'s ("Hawai'i Electric Light") Energy Cost Adjustment factor for July 2018 is 2.831 cents per kilowatt-hour ("kWh"), an increase of 0.530 cents per kWh from last month. A residential customer consuming 500 kWh of electricity will be paying \$189.43, an increase of \$2.78 compared to rates effective June 1, 2018. The increase in the typical residential bill is due to the increase in the Energy Cost Adjustment factor (+\$2.65), increase in the Purchase Power Adjustment Clause rate (+\$0.05), increase in the Public Benefit Fund Surcharge (+\$0.21), and the decrease in the Green Infrastructure Fee (-\$0.13).

Hawai'i Electric Light's fuel composite cost of generation increased 68.26 cents per million BTU to 1,538.22 cents per million BTU. The distributed generation increased to 0.819 cents per kWh to 15.772 cents per kWh. The composite cost of purchased energy decreased 0.700 cents per kWh to 14.803 cents per kWh.

The attached sheets set forth the energy cost adjustment in cents per kWh for each rate schedule that is applicable for pro rata use beginning July 1, 2018.

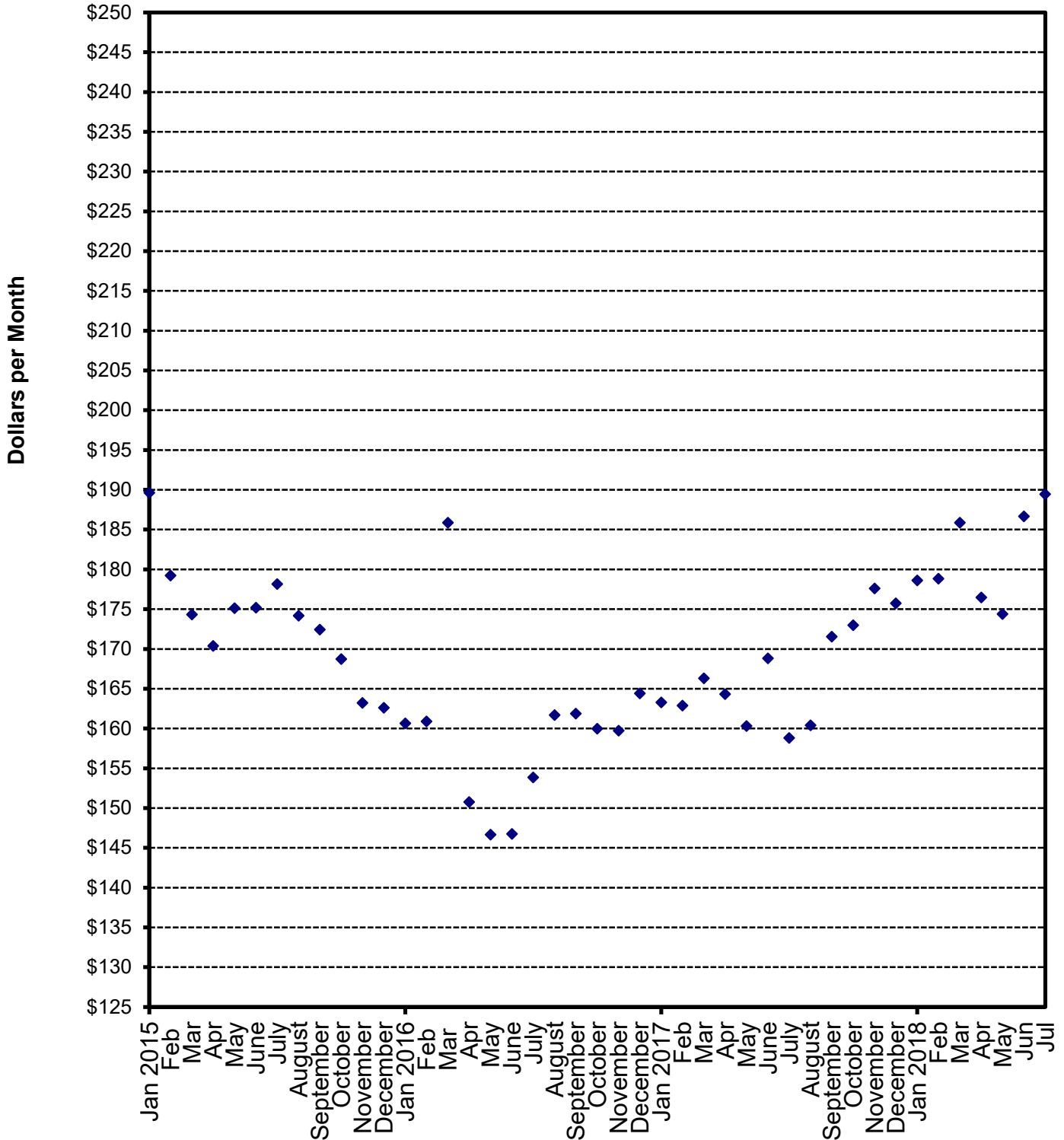
