Terms and Conditions:

1. Determination of Energy:

Standard service on and after May 15, 1976 will be unmetered dusk-to-dawn service. For the unmetered installations, the demand shall be the connected load of the lamp and appurtenances in kilowatts to the nearest 1/10. The kilowatthours shall be the connected load times 340. The demand of metered installations may be by demand or by test.

2. Standard Equipment Furnished:

Bracket or mast arm construction will be furnished and attached to existing wooden poles and secondary voltage.

3. Other Than Standard Equipment:

Where the customer requests the installation of other than the standard equipment be furnished by the Company, including underground facilities and such requested equipment is acceptable to the Company, the Company will install the requested equipment provided the customer agrees to make a contribution of the estimated difference in cost installed between such equipment and standard equipment.

Contribution made for this purpose will not be refunded. Where the customer requests fixtures to be installed on electroliers or other ornamental standards that are acceptable to the Company, in lieu of making the contribution, the customer may elect to pay added facilities charge of 1-3/4% per month of the added investment required for such facilities. Facilities installed in connection with such agreements become and remain the sole property of the utility.

4. Replacement Cost:

Where the customer requests an existing street lighting fixture or electrolier be replaced with another type, the customer shall make a contribution of the estimated cost of the new equipment installed plus the cost of the removal of the existing equipment.

SURCHARGES, CLAUSES, AND FEES:

All rates and charges applicable to this rate schedule from surcharges, clauses, and fees approved by the Commission shall be included in the customer bill, including those from the Energy Cost Recovery Clause, Purchased Power Adjustment Clause, Revenue Balancing Account Provision, Integrated Resource Planning Cost Recovery Provision, Public Benefits Fund Surcharge, Renewable Energy Infrastructure Cost Recovery Provision, and Green Infrastructure Fee Surcharge.

Special Terms and Conditions:

Non-lighting devices for security, public safety, and communication applications may be connected to street lighting facilities and served under this rate schedule. Service to such devices may be provided on either a metered or unmetered basis.

For unmetered service to non-lighting devices, the total connected load, including any unmetered street lighting load on the same service, shall not exceed 2 kW. A one-year contract is required for unmetered service for non-lighting devices, and shall remain in effect from year to year thereafter, unless, after the first year, terminated by 30 days notice in writing. The customer is responsible for notifying the Company of any changes in non-lighting loads served under the contract on a timely basis. For unmetered service, the monthly billing kilowatt-hours will be established in the contract, and will be based on equipment manufacturer's documentation or documented average consumption. If the manufacturer's documentation or documented average consumption is not available, the Customer has the responsibility of providing the information necessary to establish kilowatt-hour consumption in a manner satisfactory to the Company.

A pole mounted device is a device that is mounted on a Company approved pole. A non-lighting device is a device that is not used for lighting, and is a pole mounted device. A lower-power usage device is a device with a power requirement below the 2 kW requirement.

Rules and Regulations:

Service supplied under this rate shall be subject to the Rules and Regulations of the Company.
